

FACTORIES AMENDMENT ACT, 1936.—ORDER EXTENDING
WORKING-HOURS IN RESPECT OF SPECIFIED **AERATED-
WATER AND CORDIAL MANUFACTURERS**

In the Court of Arbitration of New Zealand.—In the matter of the Factories Amendment Act, 1936; and in the matter of applications by aerated-water and cordial manufacturers for an extension of the limits of working-hours prescribed by section 3 (1) of the said Act.

Thursday, the 8th day of March, 1945

IN pursuance and exercise of the powers vested in it by section 3 (5) of the Factories Amendment Act, 1936, this Court doth hereby order as follows:—

(1) That the limit of working-hours prescribed by paragraph (a) of subsection (1) of section 3 of the said Act is hereby extended to forty-four hours (excluding meal-times) in any one week in respect of the aerated-water and cordial manufacturing factories of the undermentioned persons, firms, and companies:—

MEMORANDUM

This order is made following on applications filed in September, 1944, by a number of occupiers of aerated-water and cordial factories for an extension to forty-four of the weekly working-hours prescribed by section 3, subsection (1) (a), of the Factories Amendment Act, 1936, such extension to operate between the 1st day of November to the 30th day of April inclusive (in each year).

In 1936 (36 Book of Awards 332) the Court decided that such an extension was necessary for this particular industry, and in six subsequent awards covering various industrial districts provision for working forty-four hours during the summer season has appeared.

We can see no justification at the present time for reversing the previous decision of the Court.
