OTAGO AND SOUTHLAND TAILORS.-AMENDMENT OF AWARD
In the Court of Arbitration of New Zealand, Otago and Southland Industrial District.-In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of an application for amendment of the Otago and Southland Tailors' award, dated the 16th day of March, 1944, and recorded in 44 Book of Awards 64.

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and upon application made by a party to the Otago and Southland Tailors' award, dated the 16th day of March, 1944, and recorded in 44 Book of Awards 64, this Court doth hereby order as follows:-

1. That the said award shall be amended--
(i) By deleting subclauses $(a)$ and ( $d$ ) of clause 3 : (Wages), and substituting therefor the following subclauses:-
" $(a)$ The minimum wage for men employed on a weekly wage, including pressers, shall be £6 1s. 8d. per week."
" (d) Pieceworkers shall be paid in accordance with thetime statement attached to the Otago and Southland Tailors ${ }^{\text {r }}$ award, dated the 8th day of December, 1938, and recorded in 38 Book of Awards 3944 at p. 3951. The said-statement shall, for the purposes of this award, be calculated at the rate of ls. 11d. per hour. Pieceworkers employed making ladies ${ }^{r}$ garments and military work shall be paid at the rate of 3s. $0 \frac{1}{2}$ d. per hour by the clock."
(ii) By deleting clause 5, and substituting therefor the following clause:-

## "Overtime

" 5. (a) All work performed beyond the hours prescribed in clause 2 hereof shall be considered overtime and shall bepaid for in accordance with the following scale:-
"Weekly Hands: From 6 p.m. until 9 p.m., time and a half; and thereafter double time. From 6 a.m. to 8 a.m., time and a half.
" Pieceworkers: From 6 p.m. until 9 p.m., 1s. 5d. per hour by the clock extra, and thereafter 2s. 10d. per hour extra by the clock. From 6 a.m. untiI 8 a.m., 1s. 5d. per hour extra by the clock.
"(b) All work performed on Saturday between the hours of 8 a.m. and 12 noon shall be paid as follows: weekly wage workers, time and a half rates; pieceworkers, 1s. 5d. per hour extra.
"(c) All work performed on Saturday after 12 noon shall be paid for as follows: weekly wage workers, at double time rates; pieceworkers, 2s. 10d. per hour extra."
2. That this order shall be deemed to have come into force on the 1st day of April, 1945.
