NORTHERN INDUSTRIAL DISTRICT BOROUGH COUNCILS AND TOWN BOARDS' OFFICERS.—AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand, Northern Industrial District.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of an application for amendment of the Northern Industrial District Borough Councils and Town Boards' Officers' award, dated the 24th day of July, 1939, and recorded in 39 Book of Awards 1012.

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and upon application made by a party to the Northern Industrial District Borough Councils and Town Boards' Officers' award, dated the 24th day of July, 1939, and recorded in 39 Book of Awards 1012, this Court doth hereby order as follows:—

1. That the said award shall be amended by deleting subclauses (a), (b), (d), and (e) of clause 3 (Rates and Conditions of Pay), and substituting therefor the following subclauses:—

(a) Except in the case of employees specifically classified, all male employees shall be paid in accordance with the following scale:— Annual Salary.

"Provided that all employees in the foregoing classification shall be paid not less than the amount to which they would be entitled according to service under subclause (a) or (b), as the case may be.

"(e) The minimum wage payable to meter-readers shall be $\pounds 234$ per annum on appointment, $\pounds 260$ during the second year, $\pounds 286$ during the third year, and $\pounds 312$ per annum during the fourth year and thereafter."

2. That for the purpose of removing doubts as to the operation of the two general orders of the Court made under the Rates of Wages Emergency Regulations 1940, and dated the 9th August, 1940, and the 31st March, 1942, respectively, it is hereby declared that the amended rates of remuneration provided by this order shall be increased to the extent and in the manner set forth in the said two general orders of the Court.

3. That this order shall be deemed to have come into force on the 1st day of April, 1945.
