WELLINGTON CITY AND SUBURBAN FIRE BRIGADES' EMPLOYEES.—AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand, Wellington Industrial District.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of an application for amendment of the Wellington City and Suburban Fire Brigades' Employees' award, dated the 11th day of September, 1942, and recorded in 42 Book of Awards 1068.

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and upon application made by a party to the Wellington City and Suburban Fire Brigades' Employees' award, dated the 11th day of September, 1942, and recorded in 42 Book of Awards 1068, this Court doth hereby order as follows:—

1. That the said award shall be amended by deleting subclauses (a), (b), (g), (h), and (j) of clause 3 (Wages), and substituting therefor the following subclauses:—

- "(g) Where a man is employed on relieving duty and has to get a meal outside of the station at which he is employed, he shall be paid the sum of 2s. per meal in each case. The provisions of clause 4 of this award increasing rates of remuneration shall not apply to the meal-money payment provided for in this subclause."
- "(h) Married men who are not provided with quarters shall be granted a house allowance of £1 4s. per week."
 - "(j) Part-time workers shall be paid as follows:-
 - "Retaining fee . . Nil.
 - "For fire duty.. For first four hours, 3s. 3½d.

 per hour or part thereof.

 For each succeeding hour,

 2s. 9½d. per hour or part
 thereof.
 - "False-alarm calls 2s. $9\frac{1}{2}$ d. per call between the hours of 10 p.m. and 6 a.m. (No payment between the hours of 6 a.m. and 10 p.m.)
 - "For night duty 2s. 9½d. per night, subject to a signing-on at 7 p.m. (minimum attendance, three nights in each week; no maximum)."
- 2. That this order shall be deemed to have come into force on the 1st day of April, 1945.
