

**TARANAKI JOURNALISTS.—AMENDMENT OF INDUSTRIAL
AGREEMENT**

In the Court of Arbitration of New Zealand, Taranaki Industrial District.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of an application for amendment of the Taranaki Journalists' industrial agreement, dated the 21st day of June, 1937, and recorded in 37 Book of Awards 1481.

IN pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and upon application made by a party to the Taranaki Journalists' industrial agreement, dated the 21st day of June, 1937, and recorded in 37 Book of Awards 1481, this Court doth hereby order as follows:—

1. That the said industrial agreement shall be amended by deleting subclause (a) of clause 6 (Payment for Services), and substituting therefor the following subclause:—

“(a) The minimum weekly salaries payable to workers subject to this agreement shall be:—

That, for the purpose of removing doubts as to the operation of the two general orders of the Court made under the Rates of Wages Emergency Regulations 1940, and dated the 9th August, 1940, and the 31st March, 1942, respectively, it is hereby declared that the amended rates of remuneration provided by this order shall be increased to the extent and in the manner set forth in the said two general orders of the Court.

3. That this order shall be deemed to have come into force on the 1st day of April, 1945.
