

NEW ZEALAND **MUSTERERS, PACKERS, AND DROVERS.**—  
AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand, Wellington Industrial District.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of an application for amendment of the New Zealand Musterers, Packers, and Drovers' award, dated the 29th day of August, 1942, and recorded in 42 Book of Awards 855.

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and upon application made by a party to the New Zealand Musterers, Packers, and Drovers' award, dated the 29th day of August, 1942, and recorded in 42 Book of Awards 855, this Court doth hereby order as follows:—

1. That the said award shall be amended—

(i) By deleting clauses 1 and 2, and substituting therefor the following clauses:—

*“Musterers' Wages*

“1. (a) Musterers, when employed to muster sheep for any purpose, shall be paid not less than £5 19s. 8d. per week if engaged by the week, and not less than £1 5s. 10d. per day if engaged by the day. Musterers engaged by the week shall receive an additional payment of £1 5s. 10d. for Christmas Day, Anzac Day, Good Friday, or any Sunday on which they are required to do any mustering, and musterers engaged by the day shall be paid for all days from the date of their commencing work until the completion of the period of employment. A musterer engaged by the day shall receive the daily rate for Christmas Day, Anzac Day, Good Friday, or any Sunday on which he is required to do mustering.

“(b) Packers employed in connection with mustering shall be paid not less than £5 1s. 8d. per week if engaged by the week, and not less than £1 2s. 10d. per day if engaged by the day. Packers engaged by the week shall receive an additional payment of £1 2s. 10d. for Christmas Day, Anzac Day, Good Friday, or any Sunday on which they are required to shift camp.

“(c) Any musterer or packer required to do snow-raking shall be paid £1 14s. 4d. per day while engaged in such work.

“(d) Reasonable shelter for dogs shall be provided at home-steads and at hill-country camps also.

*“Youths*

“2. Youths may be employed to learn mustering at not less than the following rates, in addition to their board and lodging:—

“ Thereafter, the full adult wage.”				

(ii) By deleting subclause (a) of clause 4 (Drovers’ Wages), and substituting therefor the following subclause:—

“(a) Drovers shall be paid not less than £1 15s. 4d. per day, not found, and any necessary expenses incurred on behalf of the employer shall be refunded.”

(iii) By deleting clause 5, and substituting therefor the following clause:—

*“Short Drives*

“5. When drovers are engaged on short drives, the following rates apply: for the first hour or part thereof, 6s. 9½d.; and for each additional hour or part thereof up to five hours, 4s. 9½d. per hour. All drives occupying more than five hours shall be paid for at the full daily rate of pay, time to be taken from the lifting of the stock until delivery at its destination.”

2. That this order shall be deemed to have come into force on the 1st day of April, 1945.
