OTAGO AND SOUTHLAND HOSPITAL BOARDS' LAUNDRY WORKERS.—AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand, Otago and Southland Industrial District.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of an application for amendment of the Otago and Southland Hospital Boards' Laundry Workers' award, dated the 28th day of June, 1944, and recorded in 44 Book of Awards 408.

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and upon application made by a party to the Otago and Southland Hospital Boards' Laundry Workers' award, dated the 28th day of June, 1944, and recorded in 44 Book of Awards 408, this Court doth hereby order as follows:—

- 1. That the said award shall be amended—
- (i) By deleting subclauses (a) and (b) of clause 3 (Wages), and substituting therefor the following subclauses:—

"(a) Male Workers:-

(ii) By deleting clause 7, and substituting therefor the following clause:—

" Meal-money

"7. (a) If overtime is worked after 6 p.m. the employer shall pay the worker 2s. meal-money, unless notice is given on the previous day that overtime will be worked.

"(b) If the worker is notified that overtime shall be worked on the following day and such overtime is not worked,

the employer shall pay the worker 2s. meal-money.

"(c) The provisions of clause 4 of this award increasing rates of remuneration shall not apply to the meal-money payment provided for in this clause."

2. That this order shall be deemed to have come into force on the 1st day of April, 1945.
