AUCKLAND FIRE BRIGADES' EMPLOYEES.—AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand, Northern Industrial District.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of an application for amendment of the Auckland Fire Brigades' Employees' award, dated the 12th day of June, 1942, and recorded in 42 Book of Awards 492.

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and upon application made by a party to the Auckland Fire Brigades' Employees' award, dated the 12th day of June, 1942, and recorded in 42 Book of Awards 492, this Court doth hereby order as follows:—

1. That the said award shall be amended-

(i) By deleting subclauses (a), (c), (d), and (e) of clause 2 (Wages), and substituting therefor the following subclauses:

"Provided that in respect of each of the rates of wages set out in this subclause an amount of 2s. 6d. thereof (being the amount by which the rates of wages set out in clause 2 (a). of the award dated the 29th September, 1939 (39 Book of Awards 1437) have been increased) shall be counted as part of the increase awarded by the general order dated the 31st March, 1942, under the Rates of Wages Emergency Regulations 1940."

"Provided that a worker twenty-one years of age or over shall be paid not less than £4 14s. 2d. per week, less 10s. per week if accommodation is provided by the employer."

"(d) Married men who are not provided with quarters shall be granted a house allowance of $\pounds 1$ 4s. per week."

"(e) (i) A worker when employed on relieving duty for one day at a station where there is no mess shall be paid 3s. per day as meal-money.

"(ii) A worker relieving in the case of sickness or extended leave at a station where there is no mess shall be paid at the rate of 6s. per week as meal-money."

2. That this order shall be deemed to have come into force on the 1st day of April, 1945.
