

NORTH AUCKLAND BUTCHERS.—AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand, Northern Industrial District.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of an application for amendment of the North Auckland Butchers' award, dated the 7th day of January, 1938, and recorded in 38 Book of Awards 12.

IN pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and upon application made by a party to the North Auckland Butchers' award, dated the 7th day of January, 1938, and recorded in 38 Book of Awards 12, this Court doth hereby order as follows:—

1. That the said award shall be amended—

(i) By deleting clause 3, and substituting therefor the following clause:—

“ Wages

“ 3. (a) Workers shall be paid not less than the wages specified in the following scale:—

“ In shops where both male (other than boys) and female assistants are employed, the female assistant, if in charge, shall be paid not less than £6 17s. 10d. per week.”

(ii) By deleting subclause (a) of clause 4 (Youths), and substituting therefor the following subclause:—

“(a) All youths shall be paid not less than the wages specified in the following scale:—

(iii) By deleting subclauses (a) and (b) of clause 6 (Casual Workers), and substituting therefor the following subclauses:—

“(a) Male workers employed on casual work shall be paid not less than 3s. 3½d. per hour.

“(b) Female workers employed as pork-butchers’ assistants shall be paid not less than 2s. 3½d. per hour.”

2. That, for the purpose of removing doubts as to the operation of the two general orders of the Court made under the Rates of Wages Emergency Regulations 1940, and dated the 9th August, 1940, and the 31st March, 1942, respectively, it is hereby declared that the amended rates of remuneration provided by this order shall be increased to the extent and in the manner set forth in the said two general orders of the Court.

3. That this order shall be deemed to have come into force on the 1st day of April, 1945.
