

NORTH CANTERBURY HOSPITAL BOARD **LAUNDRY WORKERS.**
—AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand, Canterbury Industrial District.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of an application for amendment of the North Canterbury Hospital Board Laundry Workers' award, dated the 9th day of March, 1944, and recorded in 44 Book of Awards 136.

IN pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and upon application made by a party to the North Canterbury Hospital Board Laundry Workers' award, dated the 9th day of March, 1944, and recorded in 44 Book of Awards 136, this Court doth hereby order as follows:—

1. That the said award shall be amended—

(i) By deleting clause 3, and substituting therefor the following clause:—

“ Meal-money

“ 3. The employer shall allow meal-money at the rate of 2s. per meal when workers are called upon to work overtime after 6 p.m.

“ The provisions of clause 14 hereof increasing rates of remuneration shall not apply to the meal-money payment provided for in this clause.”

(ii) By deleting subclause (a) of clause 4 (Wages), and substituting therefor the following subclause:—

“(a) The following shall be the minimum weekly rates of wages:—
