TARANAKI PUBLIC ACCOUNTANTS' EMPLOYEES.—AMENDMENT OF INDUSTRIAL AGREEMENT

In the Court of Arbitration of New Zealand, Taranaki Industrial District.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the Taranaki Public Accountants' Employees' industrial agreement, dated the 1st day of December, 1942, and recorded in 42 Book of Awards 1518.

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and upon application made by a party to the Taranaki Public Accountants' Employees' industrial agreement, dated the 1st day of December, 1942, and recorded in 42 Book of Awards 1518, this Court doth hereby order as follows:—

1. That the said industrial agreement shall be amended by deleting clause 2, and substituting therefor the following -clause:—

"Provided, always, that any such employee who has had any office experience in addition to accountancy experience shall be paid not less than the appropriate minimum salary payable under the Shops and Offices Act pursuant to the following scale :--Per Week. £ s. d.

"Provided, further, that the basic wage shall be paid at the appropriate time: Provided, further, that if any employee who has completed six years' accountancy experience has been admitted by examination to the New Zealand Society of Accountants, then the rates of salary for the seventh and following years above mentioned shall be increased by the sum of 10s. per week.
