NORTHERN INDUSTRIAL DISTRICT AGRICULTURAL AND PASTORAL ASSOCIATIONS, RACECOURSE, AND SPORTS BODIES' EMPLOYEES.—AMENDMENT OF AWARD

IN pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and upon application made by a party to the Northern Industrial District Agricultural and Pastoral Associations, Racecourse, and Sports Bodies' Employees' award, dated the 3rd day of October, 1941, and recorded in 41 Book of Awards 1336, this Court doth hereby order as follows:—

" Meal Allowance

"3. All workers shall be provided with a meal on racedays, or in lieu thereof a meal allowance of 2s. The allowance for meals provided for in this clause shall not be subject to the provisions of the two general orders of the Court made under the Rates of Wages Emergency Regulations 1940, and dated the 9th August, 1940, and the 31st March, 1942, respectively."

" Wages

"6. The minimum rates of pay for the undermentioned classes of workers shall be as follows:--- Per Hour.

"Any worker in charge of four or more other workers shall be paid an additional 2d. per hour.

"Work done on Sundays shall be paid for at the rate of double time with a minimum of three hours."

" Wages

"8. The minimum rate of pay shall be 2s. 9¹/₂d. per hour: Provided that the minimum payment on any one day shall be three hours' pay."

2. That for the purpose of removing doubts as to the operation of the two general orders of the Court made under the Rates of Wages Emergency Regulations 1940, and dated the 9th August, 1940, and the 31st March, 1942, respectively, it is hereby declared that the amended rates of remuneration provided by this order shall, except where otherwise provided, be increased to the extent and in the manner set forth in the said two general orders of the Court.

3. That this order shall be deemed to have come into force on the 1st day of April, 1945.
