NEW ZEALAND (EXCEPT MARLBOROUGH AND WESTLAND) CANVAS-WORKERS.—AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the New Zealand (except Marlborough and Westland) Canvas-workers' award, dated the 6th day of May, 1947, and recorded in 47 Book of Awards 815.

IN pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement-made by it on the 15th day of August, 1947, doth hereby order as follows:—

1. That the said award shall be amended in the manner following :----

(1) By deleting subclauses (a), (b), and (c) of clause 4 (Wages), and substituting therefor the following subclauses:— "(a) Journeymen shall be paid not less than 3s. 7d. per hour.

"(b) Youths.—Youths may be employed at not less than Per Week. the following rates of pay:-£ s. d. "For the first six months ... 1 10 0 " For the second six months ... 1 15 0 "For the third six months ... 2 0 0 . . 2 5 0 "For the fourth six months... . . $\frac{1}{2}$ 10 "For the fifth six months ... 0 . . $\begin{array}{ccc} 2 & 16 \\ 3 & 2 \end{array}$ "For the sixth six months ... 0 . . "For the seventh six months... 6

"Provided that workers commencing over sixteen years of age shall be paid 5s. per week in addition to the above rates; and over seventeen years of age 7s. 6d. per week in addition to the above rates; and over eighteen years of age 10s. per week in addition to the above rates; but this proviso shall not operate so as to increase journeymen's rates:

"Provided, also, that workers over twenty-one years of age shall be paid not less than £5 5s. per week.

"(c) Females.—Females may be employed at not less than the following rates of pay:— Per Week.
