

## SOUTHLAND RETAIL BUTCHERS.—AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the Southland Retail Butchers' award, dated the 18th day of December, 1946, and recorded in 46 Book of Awards 1922.

IN pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 15th day of August, 1947, doth hereby order as follows:—

1. That the said award shall be amended in the manner following:—

(1) By deleting subclause (a) of clause 2 (Wages), and substituting therefor the following subclause:—

“(a) Workers shall be paid not less than the wages specified in the following scale:—

“In any shop where a small-goods-man or second shopman is not substantially employed, the man or men doing the small-goods or serving in the shop shall receive second shopman's wages.”

(2) By deleting subclause (e) of clause 2 (Wages).

(3) By deleting the figures and symbols “2s. 10d.” in subclause (a) of clause 3 (Casual Labour), and substituting therefor the figures and symbols “3s. 4½d.”

(4) By deleting subclause (a) of clause 4 (Boys and Youths), and substituting therefor the following subclause:—

“(a) Employers may employ boys and youths at not less than the following rates:—

“Provided, however, that a youth between nineteen and twenty-one years of age who has served not less than three years at the trade shall receive £4 2s. 6d. per week.

“ And provided, further, that a youth between the age of seventeen and twenty-one years with no previous experience may be employed at a rate of 5s. less than the rates set out herein for the first six months of his employment.”

2. That this order shall come into force on the 1st day of October, 1947.
