

NEW ZEALAND (EXCEPT OTAGO AND SOUTHLAND) **LIME-
WORKERS.**—AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations, 1942; and in the matter of the New Zealand (except Otago and Southland) Lime-workers' award, dated the 26th day of September, 1946, and recorded in 46 Book of Awards 1223.

IN pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 15th day of August, 1947, doth hereby order as follows:—

1. That the said award shall be amended in the manner following:—

(1) By deleting subclause (a) of clause 3 (Wages), and substituting therefor the following subclause:—

“(a) The following shall be the minimum rates of wages:—

(2) By deleting clause 4 (Increase in Rates of Remuneration).

2. That this order shall come into force on the 1st day of October, 1947.
