

WELLINGTON INDUSTRIAL DISTRICT **ELECTROPLATERS.**—  
AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the Wellington Industrial District Electroplaters' award, dated the 22nd day of November, 1945, and recorded in 45 Book of Awards 2201.

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 15th day of August, 1947, doth hereby order as follows:—

1. That the said award shall be amended in the manner following:—

(1) By deleting clause 5, and substituting therefor the following clause:—

*“Adult Wages*

“5. The following shall be the minimum rates of wages payable to adults:—

“Electroplater with four years' or more experience	3	7
“Electroplater with less than four years' experience .. .. .	3	5¼
“First-class polisher .. .. .	3	7
“Second-class polisher .. .. .	3	5¼”

(2) By deleting clause 6, and substituting therefor the following clause:—

*“Employment of Boys and Youths*

“6. (a) Boys and youths under twenty-one years of age may be employed in the proportion of one boy and/or youth to each adult worker.

“(b) The minimum weekly rates of wages payable to such boys and youths shall be in accordance with the following scale:—

“And thereafter, or on attaining the age of twenty-one years, not less than the appropriate adult rate according to the class of work he is called upon to perform.”

(3) By deleting clause 7 (Increase in Rates of Remuneration).

2. That this order shall come into force on the 1st day of October, 1947.
