TARANAKI, WELLINGTON, MARLBOROUGH, CANTERBURY, AND SOUTHLAND PLACES OF AMUSEMENT (OTHER THAN THEATRES) AND SPORTS BODIES' EMPLOYEES.—AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the Taranaki, Wellington, Marlborough, Canterbury, and Southland Places of Amusement (other than Theatres) and Sports Bodies' Employees' award, dated the 26th day of October, 1945, and recorded in 45 Book of Awards 1891.

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 15th day of August, 1947, doth hereby order as follows:—

1. That the said award shall be amended in the manner following:-

(1) By deleting clause 3, and substituting therefor the following clause:—

" Wages

"3. (a) Except as otherwise provided in this Part of the award, workers shall be paid not less than the following rates of wages:—

"Adult males $\overset{\pounds}{6}$ 5 3 "Males under twenty years of age and females 3 14 6

- "(b) Casuals may be employed at the following minimum rates:—

 Per Hour.
 - "Adult males 3 3
 - "Adult males 3 $3\frac{3}{4}$ "Males under twenty years of age and females ... 2 6
- "A casual worker is a worker who is employed for not more than three consecutive days."
- (2) By deleting subclause (a) of clause 4 (Boxing and Wrestling Contests), and substituting therefor the following subclause:—
- "(a) The minimum rate of wages for attendants at boxing and wrestling contests shall be 10s. 4d. per performance."
- (3) By deleting clause 5, and substituting therefor the following clause:—

"Skating Rinks

- "5. For the purposes of this award a 'floor manager' is one who is competent to maintain the floor surface and supervise and control the conduct of patrons.
 - "Floor-manager: £6 10s. 6d. per week not exceeding forty hours.
- "Adult skate-room attendant who is competent and whose duty it is to adjust or repair skates: £5 17s. 5d. per week not exceeding forty hours.

- "Doorkeeper and general assistants: 9s. per performance, or £3 5s. 3d. per week not exceeding twenty hours, or £6 5s. 3d. per week not exceeding forty hours.
 - "Instructors: 9s. per performance.
- "Ticket-sellers: 9s. per performance, or £3 11s. 3d. per week not exceeding thirty-six hours.
- "Nothing in this award shall apply to skate-boys under the age of eighteen years.
- "Female cloak-room and stall attendants: 7s. 3d. per performance, or £3 11s. 3d. per week not exceeding forty hours.
- "Floor-managers, adult skate-room attendants, and female cloakroom and stall attendants shall be paid ordinary time in addition to the weekly wage for time worked over forty hours but not exceeding forty-four hours in any week."
- (4) By deleting paragraph (ii) of clause 6 (Billiard-rooms), and substituting therefor the following paragraph:—
 - "(ii) The following shall be the minimum rates of wages:—

"Night workers 4 10 0

- "Full-time workers shall be paid ordinary time in addition to the weekly wage for time worked over forty hours but not exceeding forty-four hours in any week.
- "The rate of pay for casuals shall be not less than 15 per cent. in addition to the computed hourly wage. Any worker who is employed for less than one week shall be deemed to be a casual worker."
- (5) By deleting clause 10, and substituting therefor the following clause:—

" Wages

"10. Workers covered by this Part of this award shall be paid not less than the following rates of wages:—

- (6) By deleting clause 26 (Increase in Rates of Remuneration).
- 2. That this order shall come into force on the 1st day of October, 1947.
