TARANAKI LOCAL BODIES' LABOURERS, ETC.—AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the Taranaki Local Bodies' Labourers, &c., award, dated the 5th day of June, 1947, and recorded in 47 Book of Awards 845.

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 15th day of August, 1947, doth hereby order as follows:

- 1. That the said award shall be amended in the manner following:— (1) By deleting subclauses (a) and (l) of clause 3 (Part I—Wages), and substituting therefor the following subclauses:-
- "(a) Workers covered by this Part of the award shall be paid not

less than 3s. 21d. per hour or £6 7s. per week."

"(l) Workers substantially employed in any of the capacities set out below shall be paid the hourly or weekly rates shown hereunder:—

- (2) By deleting subclause (a) of clause 3 (Part II—Wages), and substituting therefor the following subclause :—
- "(a) The minimum wages for workers covered by this Part of the award shall be as follows:—
 - "(i) Caretakers of municipal baths, Fitzroy Seaside Park, and Ngamotu Beach Reserve: £6 10s. 6d. per week.

"(ii) All other caretakers: £6 7s. 11d. per week.

"(iii) Leading hand at Pukekura Park: £6 15s. 9d. per week.

- "(iv) Leading hand employed by Hospital Boards in upkeep and maintenance of hospital gardens, grounds, and surroundings: £6 15s. 9d. per week. For the purpose of this paragraph, a leading hand is a worker in charge of two or more men.
- "(v) All other workers (except casuals): £6 7s. per week.

" (vi) Casual workers: 3s. $2\frac{1}{2}$ d. per hour.

- "(vii) A casual worker is a worker who is paid on an hourly or daily basis."
- (3) By deleting clause 7 (Part III—Increase in Rates of Remuneration).
- 2. That this order shall come into force on the 1st day of October, 1947.
