NORTHERN INDUSTRIAL DISTRICT (EXCEPT GISBORNE JUDICIAL DISTRICT) RETAIL GROCERS' ASSISTANTS AND DRIVERS.—AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the Northern Industrial District (except Gisborne Judicial District) Retail Grocers' Assistants and Drivers' award, dated the 16th day of July, 1942, and recorded in 42 Book of Awards 801.

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 15th day of August, 1947, doth hereby order as follows:—

- 1. That the said award (as amended by orders of the Court dated the 27th day of July, 1945, and the 5th day of December, 1946) shall be further amended in the manner following:—
- (1) By deleting subclauses (a) and (b) of clause 3 (Wages), and substituting therefor the following subclauses:—
- "(a) The minimum weekly rates of wages for workers shall be as follows:—
