TARANAKI, WELLINGTON, MARLBOROUGH, AND NELSON GROCERS' SUNDRIES (GENERAL) EMPLOYEES.—AMEND-MENT OF AWARD

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the Taranaki, Wellington, Marlborough, and Nelson Grocers' Sundries (General) Employees' award, dated the 5th day of December, 1946, and recorded in 46 Book of Awards 1985.
