WELLINGTON CITY COUNCIL DRIVERS.—AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the Wellington City Council Drivers' award, dated the 28th day of May, 1946, and recorded in 46 Book of Awards 421.

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 15th day of August, 1947, doth hereby order as follows :—

1. That the said award shall be amended in the manner following :---

(1) By deleting clause 2, and substituting therefor the following clause :—

"(s) A head stableman shall be deemed to be a person who has charge of a stable or stables where thirty or more horses are housed.

"(t) Where a stableman relieves the head stableman he shall receive the weekly rates of the head stableman while so employed.

"The provisions of this subclause shall not apply unless a worker relieves a head stableman for a period of not less than three days in any one pay week.

" (u) The stableman at the Clyde Quay Yard shall be paid 5s. per week extra in consideration for the early morning start.

"(v) Stableman on night shift shall be paid an additional rate of 2s. per shift."

(2) By deleting clause 3 (Increase in Rates of Remuneration).

2. That this order shall come into force on the 1st day of October, 1947.
