TARANAKI BUTCHERS.—AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the Taranaki Butchers' award, dated the 5th day of June, 1947, and recorded in 47 Book of Awards 897.

IN pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and of every other power

in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 15th day of August, 1947, doth hereby order as follows :---

That the said award shall be amended in the manner following :-- (1) By deleting subclause (a) of clause 3 (Wages), and substituting therefor the following subclause :---

" (a) Workers shall be paid not less than the wages specified in the following scale :--- Per Week.

(2) By deleting the figures and symbols "3s. $3\frac{1}{2}d$." in clause 4 (Casual Labour), and substituting therefor the figures and symbols "3s. 10d."

(3) By deleting subclause (a) of clause 5 (Boys and Youths), and substituting therefor the following subclause :—

"(a) Employers may employ boys and youths at not less than the following rates :-- Per Week.
