## NORTHERN, TARANAKI, WELLINGTON, NELSON, WESTLAND, AND CANTERBURY COACHWORKERS.—AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the Northern, Taranaki, Wellington, Nelson, Westland, and Canterbury Coachworkers' award, dated the 3rd day of June, 1940, and recorded in 40 Book of Awards 723 (in force in respect of the Taranaki Industrial District only).

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 15th day of August, 1947, doth hereby order as follows:—

- 1. That the said award shall be amended in the manner following :-
- (1) By deleting subclauses (a), (b), and (f) of clause 3 (Wages), and substituting therefor the following subclauses:—
  - "(a) The following shall be the minimum rates of wages:-

"Coachbuilders (woodmen), painters, blacksmiths, s. d. vicemen, panelbeaters, machinists, and

Assemblers over the age of twenty-one years . . 3 54
"Trimmer-assemblers over the age of twenty-one

"(f) Female workers may be employed in trimming-shops where mass production is carried on, and their operations shall be limited so as not to include machining repair work or renovations, the tacking-in of trimmings in cars, or the stuffing or making of cushions or squabs, at the following minimum rates of wages:—

(2) By inserting, after clause 3 (Wages), the following new clause :-

## " Exclusion from Operation of General Orders

- "3A. The rates of remuneration provided for in this award shall not be subject to the provisions of the two general orders of the Court made under the Rates of Wages Emergency Regulations 1940, and dated the 9th August, 1940, and the 31st March, 1942, respectively."
- 2. That this order shall come into force on the 1st day of October, 1947.
