

DUNEDIN **MILK-ROUNDSMEN.**—PARTIAL EXEMPTION FROM  
AWARD

In the Court of Arbitration of New Zealand, Otago and Southland Industrial District.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and its amendments; and in the matter of the Dunedin Milk-roundsmen's award, dated the 18th day of February, 1947 (recorded in 47 Book of Awards 179).

Monday, the 17th day of March, 1947

IN pursuance and exercise of the powers conferred on the Court by section 89 of the Industrial Conciliation and Arbitration Act, 1925, as amended by section 5 (4) of the Industrial Conciliation and Arbitration Amendment Act (No. 2), 1937, partial exemption from the Dunedin Milk-roundsmen's award, dated the 18th day of February, 1947 (recorded in 47 Book of Awards 179), is hereby granted as follows:—

1. That as to the employment of workers who at the date of making of the said award were under the age of twenty-one years, the undermentioned employers are exempted from the

provisions of clause 3 and of subclauses (a) and (b) of clause 8 of the said award from the 1st day of March, 1946, to the 31st day of March, 1947, both days inclusive.

#### MEMORANDUM

The Court has before it applications from thirty-four parties for total exemption from the Dunedin Milk-roundsmen's award made on the 18th February, 1947. The applications were heard together on the 27th and 28th February, 1947.

The Court is not satisfied that total exemption should be granted, but in the special circumstances surrounding the case has decided to grant partial exemption up to 31st March, 1947.

It is appreciated that prior to the making of the present award the workers in this industry in Dunedin have not been covered by any award or industrial agreement and that the introduction of conditions of employment of a nature similar to those which have prevailed in other centres for a number of years presents difficulties to small vendors. The Court has therefore granted partial exemption in respect of the employment of junior workers up to the 31st March, 1947, so that the small vendors may have an opportunity to arrange their systems of delivery in such a manner as to comply thereafter with the provisions of the award.
