- AUCKLAND GLASS-WORKS' EMPLOYEES.—AMENDMENT OF AGREEMENT UNDER THE LABOUR DISPUTES INVESTIGATION ACT, 1913.
- In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the Auckland Glass-works' Employees' agreement under the Labour Disputes Investigation Act, 1913, made on the 2nd day of October, 1946, and recorded in 46 Book of Awards 2305.

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 15th day of August, 1947, doth hereby order as follows:—

- 1. That the said agreement shall be amended in the manner following:—
- (1) By deleting clause 10, and substituting therefor the following clause:—
