

NORTHERN INDUSTRIAL DISTRICT STOCK AND STATION AGENTS' CLERICAL WORKERS.—AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the Northern Industrial District Stock and Station Agents' Clerical Workers' award, dated the 12th day of September, 1938, and recorded in 38 Book of Awards 2475.

IN pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 15th day of August, 1947, doth hereby order as follows:—

1. That the said award (as amended by order of the Court dated the 11th day of September, 1945) shall be further amended in the manner following:—

(1) By deleting subclause (a) of clause 2 (Salaries), and substituting therefor the following subclause:—

“(a) Subject always to the provisions of the Industrial Conciliation and Arbitration Amendment Act, 1936, relating to the basic rate of wages and to the order of the Court made thereunder, and subject also to any other statutory provision

affecting the rate of salaries payable to employees, the following shall be the minimum rate of salaries which shall be paid by the employers to the employees of the clerical staff employed by them respectively:—

(2) By deleting subclause (c) of clause 5 (Casual Workers), and substituting therefor the following subclause:—

“(c) The rates of pay for casual workers shall not be less than—

(3) By inserting, after clause 5 (Casual Workers), the following new clause:—

“Exclusion from Operation of General Orders

“5A. The rates of remuneration provided for in this award shall *not* be subject to the provisions of the two general orders of the Court made under the Rates of Wages Emergency Regulations 1940, and dated the 9th August, 1940, and the 31st March, 1942, respectively.”

2. That this order shall come into force on the 1st day of October, 1947.
