## NORTHERN, WELLINGTON, AND NELSON TOBACCO-WORKERS.— AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the Northern, Wellington, and Nelson Tobacco-workers' award, dated the 11th day of April, 1946, and recorded in 46 Book of Awards 185.

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 15th day of August, 1947, doth hereby order as follows:—

- 1. That the said award shall be amended in the manner following:—
- (1) By deleting clause 4, and substituting therefor the following clause:—

## " Wages

"4. (a) The minimum weekly rates of wages shall be as follows:—

"(ii) Combined-duties Officers: Officers combining the duties of any two or more of the following duties—health, traffic, building, and dangerous goods—shall be paid £438 7s. per annum.

"(iii) Foremen, &c.—

- "County foreman or overseer: £438 7s. per annum.
- "Borough foreman or overseer: £412 2s. per annum.

"Reserves foreman: £375 7s. per annum.

"Riding foreman or foreman under engineer, County Clerk, or Town Clerk (other than county or borough foreman): £343 17s. per annum.

"Adult chainmen: £333 7s. per annum. "Water rangers: £354 7s. per annum.

"(iv) Technical and Professional-

"First Grade: Registered architects, surveyors, engineering assistants: £438 7s. per annum.

"Second Grade: Architects, surveyors, engineering assistants: £385 17s. per annum.

"Cadets: Where cadets or chainmen under twenty-one years of age are employed, the terms of their employment shall be determined by the provisions of the Canterbury Local Bodies' Clerical Workers' award (41 Book of Awards 370)."

"(b) Special provisions for Timaru Borough Council:-

"(i) Traffic Officers—

"Where more than one traffic officer is employed— First officer: £427 17s. per annum.

"Other Officers: Other traffic officers shall be paid a commencing salary of £375 7s. per annum, with annual increases over five years until £417 7s. per annum is reached.

"(ii) Sanitary Officers-

"Chief Sanitary Inspector: £417 7s. per annum. "Sanitary Inspector (certificated): £396 7s.

per annum.

"Sanitary Inspector (uncertificated): £371 3s. per annum.

"(iii) Foremen, &c.—

"Borough engineer foreman: £438 7s. per annum.

"Waterworks foreman: £417 7s. per annum."

(2) By deleting clause 7 (Increase in Rates of Remuneration), and substituting therefor the following clause:—

## "Exclusion from Operation of General Orders

- "7. The rates of remuneration provided for in this award shall *not* be subject to the provisions of the two general orders of the Court made under the Rates of Wages Emergency Regulations 1940, and dated the 9th August, 1940, and the 31st March, 1942, respectively.
- 2. That this order shall come into force on the 1st day of October, 1947.
