

NORTHERN, WELLINGTON, AND MARLBOROUGH LOCAL  
**AUTHORITIES' OFFICERS (ELECTRIC-POWER BOARDS).—**  
AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the Northern, Wellington, and Marlborough Local Authorities' Officers' (Electric-power Boards) award, dated the 9th day of March, 1939, and recorded in 39 Book of Awards 248 (in force in respect of Marlborough Industrial District only).

IN pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 15th day of August, 1947, doth hereby order as follows:—

1. That the said award (as amended by order of the Court dated the 3rd day of November, 1945) shall be further amended in the manner following:—

(1) By deleting the figures and symbols “£312” in sub-clause (a) of clause 5 (Rates of Pay), and substituting therefor the figures and symbols “£398 9s.”

(2) By deleting the figures and symbols "£169" in sub-clause (b) of clause 5 (Rates of Pay), and substituting therefor the figures and symbols "£237 5s."

(3) By deleting the schedule of salaries in clause 5 (Rates of Pay), and substituting therefor the following schedule of salaries:—

“ Meter-reader (twenty-one years and over), £307 2s., rising as per scale to a maximum of £377 9s. at the end of the third year.

“ Cashier (male) if on duty not less than 80 per cent. of full time, £13 above Scale ‘ A,’ rising as per scale to £412 2s. at the end of eleventh year.

“ Cashier (female) if on duty not less than 80 per cent. of full time, £13 above Scale ‘ B,’ rising as per scale to £250 18s. in eighth year.”

(4) By inserting, after clause 5 (Rates of Pay), the following new clause:—

*“ Exclusion from Operation of General Orders*

“ 5A. The rates of remuneration provided for in this award shall *not* be subject to the provisions of the two general orders of the Court made under the Rates of Wages Emergency Regulations 1940, and dated the 9th August, 1940, and the 31st March, 1942, respectively.”

2. That this order shall come into force on the 1st day of October, 1947.
