NEW ZEALAND (EXCEPT NORTHERN AND OTAGO) NURSERY-MEN AND GARDENERS.—AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the New Zealand (except Northern and Otago) Nurserymen and Gardeners' award, dated the 10th day of July, 1944, and recorded in 44 Book of Awards 492.

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 15th day of August, 1947, doth hereby order as follows:—

- 1. That the said award (as amended by order of the Court dated the 31st day of August, 1945) shall be further amended in the manner following:—
- (1) By deleting subclause (a) of clause 4 (Wages), and substituting therefor the following subclause:—
 - "(a) The minimum rates of wages shall be as follows:-
