WELLINGTON, CANTERBURY, AND OTAGO AND SOUTHLAND WOOLSCOURING-WORKS' EMPLOYEES.—AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the Wellington, Canterbury, and Otago and Southland Woolscouring-works' Employees' award, dated the 9th day of June, 1947, and recorded in 47 Book of Awards 965.

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 15th day of August, 1947, doth hereby order as follows:—

- 1. That the said award shall be amended in the manner following:—
- (1) By deleting subclause (a) of clause 6 (Wages), and substituting therefor the following subclause:—
- "(a) The following shall be the minimum rates of wages for workers twenty-one years of age or over:—

 - "Woolscourer in charge of machine ... 3 9
 - $\hbox{``Wool-pressers---}\\$
 - " Hand $3 5\frac{1}{4}$ " Power $3 4\frac{3}{4}$
 - "Hydro-extractor operator ... 3 $4\frac{3}{4}$
 - "All other workers $3 \quad 3\frac{3}{4}$ "
- (2) By deleting subclause (a) of clause 8 (Employment of Youths), and substituting therefor the following subclause:—
- "(a) Boys and youths may be employed at the discretion of the employer at not less than the following minimum rates of wages:—
