AUCKLAND AND WELLINGTON FIRE BRIGADES' OFFICERS.— AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the Auckland and Wellington Fire Brigades' Officers' award, dated the 17th day of September, 1942, and recorded in 42 Book of Awards 1121 (in force in respect of Wellington Fire Board only).

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and upon application made in that behalf by a party to the Auckland and Wellington Fire Brigades' Officers' award, dated the 17th day of September, 1942, and recorded in 42 Book of Awards 1121 (in force in respect of Wellington Fire Board only), this Court doth hereby order as follows:—

- 1. That the said award (as amended by order of the Court dated the 14th day of August, 1945) shall be further amended in the manner following:—
- (1) By deleting subclauses (a), (b), and (e) of clause 1 (Wages), and substituting therefor the following subclauses:—
- "(a) The minimum rate of wages to be paid to the several grades of officers shall be as follows:—

- "(b) In consideration of extra duties and additional responsibilities which have resulted from the organization of emergency fire services, a special bonus of 5s. 3d. per week shall be paid to workers coming within the scope of this award for the term of this award or until the end of the present war, whichever shall be the lesser period."
- "(e) Married officers shall be paid an allowance for lighting of 4s. 9d. per month and for firing of 21s. per month."
- (2) By deleting clause 2 (General Orders under Rates of Wages Emergency Regulations 1940).
- (3) By deleting the figure and symbol "5s." in clause 3 (Special Duties), and substituting therefor the figures and symbols "5s. 6d."
- (4) By deleting the figures and symbol "20s." in clause 5 (Transfer), and substituting therefor the figures and symbol "21s."
- (5) By deleting paragraphs (i), (ii), and (iv) of subclause (c) of clause 15 (Special Provisions relative to the Mechanic employed by the Wellington Fire Board), and substituting therefor the following paragraphs:—
- "(i) The minimum wage payable to the mechanic employed by the Wellington Fire Board shall be £8 1s. 8d. per week.
- "(ii) In consideration of extra duties and additional responsibilities which have resulted from the organization of emergency fire services, a special bonus of 5s. 3d. per week shall be paid for the term of this award or until the end of the present war, whichever shall be the lesser period."
- "(iv) In the case of the mechanic being married, he shall be paid an allowance for lighting of 4s. 9d. per month and for firing of 21s. per month."
- 2. That this order shall be deemed to have come into force on the 1st day of October, 1947.
