

**WELLINGTON (TWENTY-FIVE-MILE RADIUS) PUBLIC
ACCOUNTANTS' EMPLOYEES.—AMENDMENT OF AWARD**

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the Wellington (Twenty-five-mile Radius) Public Accountants' Employees' award, dated the 16th day of October, 1946, and recorded in 46 Book of Awards 1441.

IN pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 15th day of August, 1947, doth hereby order as follows:—

1. That the said award shall be amended by deleting sub-clause (a) of clause 2 (Salaries), and substituting therefor the following subclause:—

“(a) The following shall be the minimum salaries payable to employees:—
