NORTHERN, WELLINGTON, CANTERBURY, AND OTAGO AND SOUTHLAND CARDBOARD-BOX, CARTON, AND PAPER-BAG MAKERS.—AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act. 1925. and the Economic Stabilization Emergency Regulations 1942: and in the matter of the Northern. Wellington.

Canterbury, and Otago and Southland Cardboard-box. Carton, and Paper-bag Makers' award, dated the 14th day

of August, 1947, and recorded in 47 Book of Awards 1377.

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 15th day of August, 1947, doth hereby order as follows:—

- 1. That the said award shall be amended in the manner following:—

"(i) Feeders.—Male and female feeders employed on the classes of work provided for in subclauses (a) and (d) of this clause shall not alter the adjustments of the machines, except such as are necessary in washing up and starting and stopping the machine. They shall not do any make-ready."

(2) By deleting clause 4 (Increase in Rates of

Remuneration).

2. That this order shall be deemed to have come into force on the 1st day of October, 1947.
