

NEW ZEALAND HARBOUR BOARDS' EMPLOYEES.—
AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the New Zealand Harbour Boards' Employees' award, dated the 4th day of July, 1947, and recorded in 47 Book of Awards 1121.

IN pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and upon application made in that behalf by parties to the New Zealand Harbour Boards' Employees' award, dated the 4th day of July, 1947, and recorded in 47 Book of Awards 1121, this Court doth hereby order as follows:—

1. That the said award (as amended by orders of the Court dated the 22nd September, 1947, and the 4th December, 1947) shall be further amended by adding to the appendix the following provisions relating to the Port of Greymouth:—
