## NORTH ISLAND DAIRY-FACTORY MANAGERS.—AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand, Northern, Taranaki, and Wellington Industrial Districts.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and its amendments; and in the matter of the North Island Dairy-factory Managers' award, dated the 27th day of July, 1945, and recorded in 45 Book of Awards 937. UPON reading the joint application for amendment of the North Island Dairy-factory Managers' award, dated the 27th day of July, 1945, and recorded in 45 Book of Awards 937, this Court, in pursuance and exercise of the powers vested in it by section 92 (1) (c) of the Industrial Conciliation and Arbitration Act, 1925, and of every other power in that behalf thereunto enabling it, and with the consent of the parties, doth hereby order as follows :---

1. That the said award shall be amended in the manner following :---

(i) By deleting the figures "£325" in subclause (a) of clause 1, and substituting therefor the figures "£377."

(ii) By deleting the figures " $\pounds 305$ " in subclause (b) of clause 1, and substituting therefor the figures " $\pounds 357$ ."

(iii) By deleting the figures "£375" and the figures "£475" in subclause (c) of clause 1, and substituting therefor the figures "£427" and the figures "£527" respectively.

(iv) By deleting subclause (d) of clause 1, and substituting therefor the following subclause :—

"Dual-plant Factories and Cheese-factories making Their Own Wheybutter.—The tonnage shall be computed on the total tonnage of cheese and butter added together, and the cheese schedule shall be the basis on which the combined total is calculated for payment."

(v) By deleting clause 8 (Accident Insurance).

(vi) By deleting clause 12, and substituting therefor the following clause :--

## " General

"12. Managers subject to this award shall be entitled to one day off in each week to be taken at a time to suit the work of the factory. If a manager is called upon to work on more than six days in any week he shall be paid at the rate of 7s. 6d. per hour for all time worked on the seventh day, with a maximum payment of £3 for any day : Provided always that the manager shall comply with such rules as his employer shall lay down in respect of determining the need to work and verification of the time worked.

"Where a manager is required to pull presses after the ordinary factory work is finished, he shall be paid 3d. per press per day."

(vii) By deleting the words and figures "31st day of May, 1947," in clause 16, and substituting therefor the words and figures "31st day of May, 1948."

2. That this order, except subclauses (i), (ii), (iii), and (iv) of clause 1, shall come into force on the day of the date hereof. Subclauses (i), (ii), (iii), and (iv) of clause 1 shall be deemed to have come into force on the 1st day of August, 1946.
