

NORTHERN INDUSTRIAL DISTRICT (EXCEPT AUCKLAND  
(TWENTY-ONE-MILE RADIUS) AND GISBORNE JUDICIAL  
DISTRICT) **BUTCHERS**—AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations, 1942; and in the matter of the Northern Industrial District (except Auckland (Twenty-one-mile Radius) and Gisborne Judicial District) Butchers' award dated the 11th day of October, 1946, and recorded in 46 Book of Awards 1382.

IN pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations, 1942, and of every other power in that behalf thereunto enabling it, this

Court, for the purpose of giving effect to the pronouncement made by it on the 12th day of April, 1949, doth hereby order as follows:—

1. That the said award (as amended by order of the Court dated the 29th day of August, 1947), shall be further amended in the manner following:—

(1) By deleting clause 3 (Wages) and substituting therefor the following clause:—

*“ Wages*

“ 3. Workers shall be paid not less than the wages specified in the following scale:—

(2) By deleting subclause (b) of clause 4 (Boys and Youths) and substituting therefor the following subclause:—

“ (b) All boys and youths shall be paid not less than the wages specified in the following scale:—

(3) By deleting subclause (a) of clause 6 (Casuals), and substituting therefor the following subclause:—

“ (a) Male workers employed on casual work shall be paid not less than 4s. 3d. per hour.”

(4) By deleting subclause (c) of clause 7 (Employment of Females), and substituting therefor the following subclause:—

“(c) In the area defined in subclause (b) of this clause female shop-assistants shall be paid not less than the rates specified in the following scale:—

“In shops where both male (other than boys and youths) and female assistants are employed, the female assistant, if in charge, shall be paid not less than ..	8 16 8”

2. That this order shall come into force on the 1st day of June, 1949.
