NORTHERN INDUSTRIAL DISTRICT RETAIL-SHOP ASSISTANTS— AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the Northern Industrial District Retail-shop Assistants' award, dated the 23rd day of October, 1947, and recorded in 47 Book of Awards 2241.

IN pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 12th day of April, 1949, doth hereby order as follows:—

"This award shall not apply to storemen and packers covered by any Wholesale Merchants' Storemen and Packers' award."

2. That this order shall come into force on the 1st day of June, 1949.
