- 1. That the said award (as amended by order of the Court dated the 6th day of September, 1947) shall be further amended in the manner following:—
- (1) By deleting subclause (a) of clause 3 (Wages) and substituting therefor the following subclause:—
- "(a) Adult male shop-assistants shall be paid not less than the wages specified in the following scale:—
 - "Shopman in charge of shop with total staff £ s. d. of assistants of four or more in number 8 8 9
 - "First shopman or man in charge of shop 7 18 3
 - "All other adult male shop-assistants ... 7 7 9"
- (2) By deleting clause 4, and substituting therefor the following clause:—

- "7. Casual workers shall be paid at the rate of not less than 4s. $1\frac{1}{2}$ d. per hour. 'Casual' shall mean any person whose engagement is for a period of less than five consecutive days.".
- 2. That this order shall come into force on the 1st day of June, 1949.
