## NORTH ISLAND ELECTRICAL WORKERS (POWER BOARDS, ETC.)—AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act. 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the North Island Electrical Workers (Power Boards, &c.) award, dated the 26th day of August, 1948, and recorded in 48 Book of Awards 1441.

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 12th day of April, 1949, doth hereby order as follows:—

f''(g) Youths may be employed in a proportion not greater than one youth to each five men employed on lines and not more than one youth in each gang. "A youth shall be afforded the opportunity of learning all branches of line work, the syllabus of training shall generally be in accordance with that agreed to between the union and the Power Supply Authorities Engineers' Association, and the list of skills and operations to be taught shall be listed and filed with the union in each instance.

"During the first year of employment, such youths shall be employed on ground work.
