TARANAKI, WELLINGTON, MARLBOROUGH, CANTERBURY, AND SOUTHLAND PLACES OF AMUSEMENT (OTHER THAN THEATRES) AND SPORTS BODIES' EMPLOYEES—AMENDMENT OF AWARD

[Filed in the Office of the Clerk of Awards, Wellington]

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the Taranaki, Wellington, Marlborough, Canterbury, and Southland Places of Amusement (Other Than Theatres) and Sports Bodies' Employees' award, dated the 8th day of December, 1947, and recorded in 47 Book of Awards 2990.

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it, on the 12th day of April, 1949, doth hereby order as follows:—

- 1. That the said award shall be amended in the manner following:—
- (1) By deleting clause 3 and substituting therefor the following clause:—

" Wages

"(b) Casuals may be employed at the following minimum rates:—

"Youths and females 2 9

- "A casual worker is a worker who is employed for not more than three consecutive days."
- (2) By deleting subclause (a) of clause 4 (Boxing and Wrestling Contests) and substituting therefor the following subclause:—
- "(a) The minimum rate of wages for attendants at boxing and wrestling contests shall be 11s. 9d. per performance."

(3) By deleting clause 5, and substituting therefor the following clause:—

" Skating-rinks

- "5. The following shall be the minimum rates of wages for workers at skating-rinks:—
 - "Floor-manager who is competent to maintain the floor surface and control the conduct of patrons: £7 2s. 2d, per week not exceeding forty hours.
 - "Adult skate-room attendant who is competent and whose duty it is to adjust or repair skates: £6 9s. 8d. per week not exceeding forty hours.
 - "Doorkeepers and general assistants: 11s. 3d. per performance, or £3 13s. 4d. per week not exceeding twenty hours, or £6 19s. 2d. per week not exceeding forty hours.
 - "Nothing in this award, other than clauses 11 and 13, shall apply to managers of skating-rinks in receipt of not less than £500 per annum, exclusive of overtime.
 - "Instructors: 11s. 3d. per performance.
 - "Ticket-sellers: 11s. 3d. per performance, or £4 4s. 6d. per week not exceeding forty hours.
 - "Nothing in this award shall apply to skate-boys under the age of eighteen years.
 - "Female cloak-room attendants: 9s. 9d. per performance, or £4 4s. 6d. per week not exceeding forty hours.
 - "For the purpose of this clause a performance shall not exceed three and a half hours."
- (4) By deleting subclause (ii) of clause 6 (Billiard-rooms) and substituting therefor the following subclause:—
 - "(ii) The following shall be the minimum rates of wages:—

Full-time workers 6 16 8

"Night workers 5 1 3

"The rate of pay for casuals shall be not less than 15 per cent. in addition to the computed hourly wage. Any worker who is employed for less than one week shall be deemed to be a casual worker."

(5) By deleting clause 7, and substituting therefor the following clause:-

" Dancing-halls and Cabarets

"7. (a) The minimum rates of wages for attendants at dance-halls and cabarets shall be-

Per Performance. "Masters of ceremonies "Other attendants ... 0 19

"(b) The ordinary hours for all performance workers shall not exceed five hours, to be worked continuously and to finish

not later than midnight.

"(c) For all work done between the hours of 12 midnight and 2 a.m., 3s. 74d. per hour or part thereof shall be paid in addition to the above rates; thereafter, 7s. 2½d. per hour.

"This subclause shall not apply to performances commencing between the hours of 12 midnight and 6 a.m."

(6) By deleting clause 10, and substituting therefor the following clause:-

" Wages

"10. Workers covered by this Part of this award shall be paid not less than the following rates of wages:-

"(b) The minimum rates of wages for workers employed at agricultural and pastoral society shows shall be:-

" All other male workers 1 "Female workers ... 1

"(ii) Where a worker is employed for less than four hours, 3s. 71d. per hour, with a minimum of two and a half hours."
