(1) By deleting the symbols and figures " $\pounds 7$ 12s." in subclause (b) of clause 1 (Industry to Which Award Applies) and substituting therefor the symbols and figures " $\pounds 8$ 5s. 4d."

(2) By deleting subclauses (a) and (b) of clause 2 (Salaries), and substituting therefor the following subclauses:—
