NEW ZEALAND BAKERS AND PASTRYCOOKS AND THEIR LABOURERS—AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations, 1942; and in the matter of the New Zealand Bakers and Pastrycooks and Their Labourers' award, dated the 10th day of September, 1948, and recorded in 48 Book of Awards 1633.

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations, 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 12th day of April, 1949, doth hereby order as follows:—

- 1. That the said award shall be amended in the manner following:—
- (1) By deleting subclause (a) of clause 3 (Wages) and substituting therefor the following subclause:—
 - "(a) The minimum rates of wages shall be as follows:-

(2) By deleting subclause (a) of clause 4 (Jobbers) and substituting therefor the following subclause:—

"(a) A journeyman jobber shall be paid not less than £1 13s. per day or a labourer £1 8s. 4d. per day of eight hours. He shall be paid not less than five hours' wages in any event. If he is employed for less than eight hours he shall be paid not less than 4s. 11d. per hour for a journeyman jobber and not less than 3s. 61d. per hour for a labourer jobber."

(3) By deleting subclause (a) of clause 7 (Junior Labourers) and substituting therefor the following

clause:--

"(a) Subject to the provisions and restrictions contained in subclause (d) of clause 3, junior labourers may be employed at not less than the following rates:-
