OTAGO AND SOUTHLAND RETAIL CHEMISTS' ASSISTANTS— AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations, 1942; and in the matter of the Otago and Southland Retail Chemists' Assistants' award, dated the 29th day of August, 1946, and recorded in 46 Book of Awards 932.

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations, 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 12th day of April, 1949, doth hereby order as follows:—

1. That the said award (as amended by order of the Court dated the 10th day of September, 1947) shall be further amended by deleting clause 5 and substituting therefor the following clause:—

"(ii) Any such assistant or manager who is required to live away from his permanent home shall receive a board allowance of £2 5s. per week, or the employer may provide board and lodging in lieu thereof.

"(d) Any worker employed in a chemist's shop other than those referred to in subclauses (a), (b), (c), (d), and (e) of clause 2 or in subclause (e) of this clause shalls be paid not less than the following rates of wages:

2. That this order shall come into force on the 1st day of June, 1949.
