## OTAGO AND SOUTHLAND ROPE AND TWINE WORKERS— AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the Otago and Southland Rope and Twine Workers' award, dated the 28th day of May, 1948, and recorded in 48 Book of Awards 801.

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 12th day of April, 1949, doth hereby order as follows:—

1. That the said award shall be amended by deleting clauses 3, 4, and 5 and substituting therefor the following clauses:—

## " Wages

"3. The minimum rates of wages for adult male workers shall be as follows:—

## " Youths

"4. (a) Youths may be employed in the proportion of one youth to every two men employed: Provided that no youth under twenty years of age may be employed on night shifts.

"(b) The minimum weekly rates of wages payable to youths shall be as follows:—
