

NEW ZEALAND **TAXI-TELEPHONISTS**—AMENDMENT OF  
AWARD

*[Filed in the Office of the Clerk of Awards, Auckland]*

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations, 1942; and in the matter of the New Zealand Taxi-telephonists' award, dated the 25th day of September, 1946, and recorded in 46 Book of Awards 1263.

IN pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations, 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 12th day of April, 1949, doth hereby order as follows:—

1. That the said award (as amended by order of the Court dated the 21st day of November, 1947) shall be further amended in the manner following:—

(1) By deleting subclause (b) of clause 2 (Definitions) and substituting therefor the following subclause:—

“(b) A senior is a worker entitled to receive, under clause 3 (a) or 3 (b), £6 12s. 8d. per week or more in the case of males and £4 6s. 6d. per week or more in the case of females.”

(2) By deleting clause 3 (Wages), and substituting therefor the following clause:—

“ Wages

“3. The minimum rates of weekly wages shall be as follows:—

“(a) Males—

Age Commencing Employment.	First Year.	Second Year.	Thereafter.
Under 20 .. .. .	66/-	92/6	132/8
20 to 21 .. .. .	92/6	114/2	132/8

“ Provided that a worker of the age of twenty-one years or upwards shall receive not less than the rate provided in the Minimum Wage Act.

“(b) Females—

Age Commencing Employment.	First Year.		Second Year.		Thereafter.

“ Provided that a worker of the age of twenty-one years or upwards shall be paid not less than the rate provided in the Minimum Wage Act.

“(c) Provided that switchboard attendants shall be paid additional rates to the above as follows:—

“ Senior males, 10s. 6d. per week.

“ Senior females, 10s. 6d. per week.

“ Junior males, 5s. 6d. per week.

“ Junior females, 3s. per week.

“(d) Where a staff of six or more telephonists are employed, the worker in charge shall receive not less than £7 5s. 8d. per week, and at least two others shall be paid not less than the senior rate. Where twelve or more are employed, at least four others shall be paid not less than the senior rate.”

2. That this order shall come into force on the 1st day of June, 1949.
