NORTHERN INDUSTRIAL DISTRICT LEGAL EMPLOYEES— AMENDMENT OF INDUSTRIAL AGREEMENT

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the Northern Industrial District Legal Employees' industrial agreement, made on the 19th day of October, 1946, and recorded in 47 Book of Awards 20.

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and of every other power in that behalf thereunto enabling it, this

Court, for the purpose of giving effect to the pronouncement made by it on the 12th day of April, 1949, doth hereby order as follows:—

1. That the said industrial agreement (as amended by order of the Court dated the 8th day of December, 1947) shall be further amended by deleting subclauses (a), (b), (c), (d). (f), and (g) of clause 7 (Salaries) and substituting therefor the following subclauses:—

- "(g) Notwithstanding anything to the contrary hereinbefore contained, every male law clerk or law student shall receive a minimum wage of £4 6s. 8d. upon attaining twenty-one, and every female employee shall receive a minimum wage of £3 18s. upon attaining twenty-one."
- 2. That this order shall come into force on the 1st day of June, 1949.
