

WELLINGTON (TWENTY-FIVE MILE RADIUS) **PUBLIC**
ACCOUNTANTS' EMPLOYEES—AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations, 1942; and in the matter of the Wellington (Twenty-five Mile Radius) Public Accountants' Employees' award, dated the 16th day of October, 1946, and recorded in 46 Book of Awards 1441.

IN pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations, 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 12th day of April, 1949, doth hereby order as follows:—

1. That the said award (as amended by order of the Court dated the 16th day of December, 1947) shall be further amended by deleting subclause (a) of clause 2 (Salaries) and substituting therefor the following subclause:—

“(a). The following shall be the minimum salaries payable to employees:—

2. That this order shall come into force on the 1st day of June, 1949.
