UNION STEAM SHIP COMPANY OF NEW ZEALAND, LIMITED— MARINE ENGINEERS AND ELECTRICIANS—AMENDMENT OF AGREEMENT

In the Court of Arbitration of New Zealand.—In the matter of the Labour Disputes Investigation Act, 1913, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the Union Steam Ship Company of New Zealand, Limited, Marine Engineers and Electricians' agreement, made on the 17th day of December, 1947, and recorded in 47 Book of Awards 3361.

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 12th day of April, 1949, doth hereby order as follows:—

- 1. That the said agreement shall be amended in the manner following:—
