In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and of every other power in that behalf thereunto enabling it, this

Court, for the purpose of giving effect to the pronouncement made by it on the 12th day of April, 1949, doth hereby order as follows:—

1. That the said industrial agreement shall be amended by deleting clause 4 and substituting therefor the following clause:—

"The basic wage shall apply in the case of both female and male workers, including typists, on the worker reaching the age of twenty-one years.

"Senior female typists, with a minimum of seven years of service and female machine operators shall receive £10 per annum in addition to the rates prescribed in the wages schedule."
