ONEHUNGA BOROUGH COUNCIL CLERICAL AND OTHER OFFICERS—AMENDMENT OF INDUSTRIAL AGREEMENT

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the Onehunga Borough Council Clerical and other Officers industrial agreement, made on the 3rd day of December, 1948, and recorded in 48 Book of Awards 2733.

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 12th day of April, 1949, doth hereby order as follows:—

- 1. That the said industrial agreement shall be amended by deleting subclauses (f), (g), and (h) of clause 3 (Remuneration or Wages) and substituting therefor the following subclauses:—

Any person passing such test of efficiency during any year shall receive any increase to which she is entitled through passing such test as from the 1st April or the 1st September next following the date on which such qualification is obtained.
- "A worker who for 75 per cent. of his or her time acts as a cashier shall be paid 6s. per week in addition to the rate to which such worker is entitled under clause 3.

"Where any person, by reason of a double qualification is entitled to two or more additional payments, he shall receive only the higher

amount provided for in this agreement.

"Any person employed by the Council, gaining any of the above qualifications during any year, shall receive any increase to which he is entitled through gaining such qualification as from the 1st April next following the date on which such qualification is obtained."

2. That this order shall be deemed to have come into force on the

1st day of June, 1949.
